**Policy & Government Affairs:**  
In 2014, the Policy & Government Affairs program focused on passage of 15 new Vision Zero laws and resolutions in the City Council, as well as worked with City agencies to pass rules for for-hire drivers. Additionally, we monitored the City's processes around streamlining and expediting play streets and speed camera requests, worked with City Council to amend existing bike access to buildings and outdoor bike parking laws, and advocated for a car-free September Central Park trial.

**Campaigns & Organizing:**  
The overarching goal of T.A.'s Campaigns & Organizing program is to engage and empower New Yorkers to increase biking, walking and public transit options and achieve vision zero-zero deaths or serious injuries in traffic. In 2014, T.A. organized around passage of a 25 mph speed limit for New York City at both the City Council and Albany legislature. We launched 9 new Complete Streets campaigns in 5 boroughs, and made significant progress on 8 other campaigns. Six of our arterial campaigns are being actively studied by the NYC DOT. T.A. garnered over 22,000 petition signatures in support of these campaigns and added over 610 new members to our 5 borough based Activist Committees. Additionally, we launched the Families for Safe

**Outreach Tours & Events:**  
T.A.'s five annual bike tours provide an entry-level path to on-street bicycling. Our borough tours in Brooklyn, Queens, Staten Island and the Bronx are 20-mile, family-oriented bicycle parades that loop through neighborhoods where New York City's bicycling population has exploded. Our premier bicycle tour, the NYC Century Bike Tour, hosts an audience of over 7,000 bicyclists and the nation's only all-urban 100-mile route.
